2	Permitting additional 2 floors with TDR	May be permitted subject to maintaining minimum 7 mts setback at Tower level.
3	Setback relaxation in road widening case	May be considered only at Tower level subject to maintaining minimum 7 mts setback at Tower level and no setback relaxations shall be given at Podium level.
4	Combination of Podium and Tower buildings with regular buildings in the same site	May be permitted subject to maintaining required setback as per building rules between Podium Block and Regular Building.
